The county is 520 Km long and 330 Km wide as the crow flies, has a wide outlet on the Black Sea and the river Danube. Bulgaria occupies the eastern part of the Balkan Peninsula; the area is 111.000 sq km. To the north it borders on Romania, to the west on the Republic of Macedonia and Serbia, to the east on the Black Sea, to the south on Greece and to the southeast on Turkey's European part. It is convenient crossroads between Europe and Asia.
